As you can see on the on the graph here, we've had some ups and downs. Obviously with COVID we took a real hit, and I'm surprised that we actually had that many kids, but we're on the uptick now. So hopefully that trend will continue. We have a lot of programs in place, some of which I'll touch on later, but trying to attract new players, kids who have perhaps never considered hockey in the past. So, as you can see on the graph, we are at 464 registrants this year, which is up 30 from last year. I think that on some of things that need to be mentioned here is that with the Upper York pilot, we got back some kids that were playing another centers, playing AA and other places, but we're still experiencing a little bit of a drop off with our U8 and U9 HL numbers. Some of those kids left to explore the new league that is available outside of Hockey Canada for that age group, but overall, the trend is on the uptick, and we hope to keep things going in the right direction.

Brad Russell – Player and Coach Development

We continued our goaltender clinics on Saturday mornings with Dwayne Crocker from the Goalie School. He was very well liked and the clinics were very well attended this year, which was which was excellent.

For Sunday morning skating sessions we brought in skating instructor Alexa Matveev, she was a national figure skating champion for Canada to run power skating clinics.

For our coaches, we had Chris Di Piero come out from CEP mindset, mental performance and leadership coaches. Again, very well received by our coaches. We also procured ice hockey systems memberships for coaches, which provided practice planning tools and videos to watch of drills to run.

For checking clinics, we partnered with Upper York to ensure consistency with GMHA and EGMHA.

Moving forward, we have decided to hire a IP Instructor, Joe McTamney will be running that program on Saturdays for us next season. He's a professional hockey coach and also runs GMHA's IP program as well. We are looking to again ensure consistency across the board so that our kids have the same opportunity as the Georgina kids rolling into Rep programming at U10 and above. This will also serve as coach training.

Jeff Mackey – VP Rep

EGMHA had 2 MD teams (U8 and U9), U10 and up participated in Rep hockey with the Upper York Admirals Pilot. U8 numbers were low, so borrowed some players from GMHA to run the U8MD team.

So in the overall there was 429 Upper York players that EG represented 45% of those overall players. When you further break it down into AA, 62% of those were EG residents, for A players



35% were EG and then between the B, the double B and the C team that we iced again 35% were EG residents.

Several of the Upper York teams saw success early on in, in some of the early bird tournaments.

There were 25 total teams between the different all the age groups and the different levels we had the U15 AA win the York Simcoe championship.

Three teams (U10A, U14 BB and U15 AA) qualified for the OMHA championships, where U15 AA finished the highest as a semi-finalist.

Going forward we are finalizing teams now for U16 and below, and will be working on the Upper York ByLaws and the merge will go to an official vote in EGMHA and GMHA this Fall.

Sherri Annis - LL Update

EGMHA had 9 teams in the Simcoe Region Local League this year.

2 U11, 2 U13, 2 U15, 1 U16, 2 U18

We had many teams advance to the SRLL Playoff Rounds

Tournaments

Hosted three tournaments this year. In total, the tournaments combined raised \$18,955.

Friendship Jamboree

- U8MD teams participated in the tournament which raised \$2,960
- Ran smoothly, no challenges reported

Winter Classic

- 53 Teams participated
- U9 MD, U11 to U18 HL/LL participated in the tournament which raised \$7,215
- Timing coinciding with high school final exams, issues with finding timekeepers during day Friday

Dunsmuir Memorial

- Total of 57 teams, U10 A to U18 A, also including U13 AA division participated in the tournament which raised \$8,780

PROPOSED AMENDMENT 4

Moved by: EGMHA member - Michael Mendes

Rationale for change: not provided

Proposed Addition:

1.x Tournament income from any other tournament shall be deposited in the General Fund account.

Existing Policy:

- 1.5 Amounts designated as 'annual dues' shall be deposited in an account known as the EGMHA's 'contingency fund' which shall be partitioned as follows:
 - (a) All monies will go towards the operational contingency fund first until it reaches the required minimum level equal to 10% of revenues. Thereafter, all funds are divided as follows:
 - (b) 80% of monies towards the Association Fund, which may be used to benefit the Association and its members as a whole



(c) 20% of monies towards the operational contingency fund, which may be allocated at the discretion of the following year's executive

Proposed Revision:

- 1.5 Amounts designated as 'annual dues' shall be deposited in an accounts known as the EGMHA's Restricted 'Association and Operating Contingency Funds' which shall be partitioned as follows:
 - (a) A minimum of 5% of all monies will go towards an invested GIC Reserve Fund, until it reaches the required maximum of half a year's revenue. Thereafter, all funds are divided as follows:
 - (b) 80% of monies towards the Restricted Association Fund, which may be used with member approval for rink, office and facilities improvements, special events and other approved activities.
 - (c) 20% of monies towards the Restricted Operating Fund, which may be used by the Board to fund equipment purchases, trophy upgrades, computers, software, or any item for which the cost exceeds any current year benefit and should not be funded out of current year registration fees. The Operating Fund can also be used as a source of operating funds should the General account funds be insufficient for day-to-day cash flow needs.

After discussion that the changes to come, the motion was also **WITHDRAWN**.

PROPOSED AMENDMENT 5

Rationale for change: not provided

Existing Policy:

3.3 The Executive Committee shall determine the amount required for annual registration fees with foremost consideration given to EGMHA's aims and objectives as well as an amount up to the equivalent of ten percent (10%) of player registration fees shall constitute Annual Dues for deposit to the Contingency Fund. This allocation towards contingency shall be determined on an annual basis.

Proposed Revision:

3.3 The Executive Committee shall determine the amount required for annual registration fees to ensure the statement of operations are balanced each year with foremost consideration given to EGMHA's aims and objectives as well as an amount up to the equivalent of ten percent (10%) of player registration fees shall constitute 'Annual Dues' for deposit to the Restricted 'Association and Operating Funds'.

ONCA AMENDMENTS

Changes are required to comply with the Ontario Non Profit Corporation Act. Had a change in their legislation that required all organizations by October of 2024 to comply with the new ONCA bylaw and articles that they require under legislation.

We've gone through all the requirements and one of the things we realized when we were going through the ONCA requirements, is that our Constitution is actually bylaws and our bylaws in our Constitution are actually policies. Your Constitution is actually the articles that are filed. What would have been our previous letter of patent and now what's going to be our articles of amendment are going to be submitted to the government of Ministry of Government and Consumer Services

Under ONCA your article talk about how your organization is structured and what you're voting membership is.

Then we also are proposing a series of bylaws that ONCA requires us to have that are more corporate, and our day to day operations are governed by a General Operating Policy.

These changes are in line with what Newmarket Minor Hockey has recently passed. It's modeled very similarly under theirs, and following the guidance provided by ONCA.

There's a couple distinctions in the new Articles, ByLaws and Policies from our current one Constitution/ByLaw document, with the new General Operating Policy your Executive Board can now make changes that are operationally makes sense with how your organization evolves.

The ByLaws though still have to go to a membership vote if you want to change any there, a membership vote is required.

What to Expect Next Season

Upper York Admiral Spring evaluations (tryouts) were completed on Sunday for U10 to U16 for AA, A and B/BB. With the amalgamation were have successfully been able to roster AA, A and B/BB teams at each age group

Development skates to run in September prior to tryouts for U18. September tryouts for U8/U9 MD and U18 AA,A,B/BB. Early October tryouts for U7 Select (numbers pending).

Planning to run all three tournaments again next season and new one in the Spring:

- Friendship Jamboree (U8 MD teams)
- Winter Classic (U9MD, U9-U18 HL/LL teams)
- Dunsmuir Memorial Tournament (U10-U18 A teams)
- Spring Fling (A and B/BB teams)

EGMHA will be running Ball Hockey at Mount Albert Sports Day, please come by and visit.

Regular season programming is planned to begin in September.

New Competitive Player Pathway Program in YSMHL for U7, U8 and U9 Select teams, we hope to field teams in all three divisions.

In the fall will be running the Bauer First Shift Program.

OMHA has proposed all teams will be scored using iPads via GameSheet Inc. Live scoring and updates will be available for Rep and Local League (where there is WiFi access)

New draft selection process for U9 to U18 divisions will run next season.

U9 to U13 divisions will participate in an Interlock House League with Georgina Minor Hockey, surveying U15 to U18 divisions to see what their preference is, whether they want to try the Interlock or stay with Simcoe Region Local League.

New Sponsorship program with KidSpired will be implemented.

Moving into our second year of our two-year pilot with Georgina Minor Hockey to develop the Upper York Admirals. Will keep working towards completing the requirements to bring the Upper York Admirals pilot project to a permanent amalgamation membership vote in Fall 2024

Slight increase in some division for Registration as Ice costs with the Town have gone up, but U11 to U13 are lower due to the Interlock House League option. Once again will have \$100 discount for third family member playing. There is an increase of the late fee to \$100. Visit the EGMHA website if there are families that need assistance, also noted that the Town of EG Youth and Community fund is currently open for members that may need assistance playing hockey.

Questions and Answers

Question: With our numbers so low last year and local loop, what are we doing to address that this upcoming season?

• We are working with the Upper Admirals Group that we participate on the board to make sure that we're not draining our numbers by having teams that you know would decimate our local league. It's tough because the OMHA directive, if you will, is that we provide, the highest level hockey available to each and every player that wants it. So we do have a little juxtaposed thing there where we have to offer them these opportunities, but if the o opportunities end up decimating our programming at locally and House League, then obviously we have we have to step back from that. We ever want to have to turn kids away. So part of what we are doing to build those numbers is reaching out to people through our community engagement to try and bring more kids in.

Question: There were updates throughout the meeting about how many players were playing in Upper York from EG and some of the successes, are you saying they may have been over zealous with the number of Upper York teams run?

• So we have a little bit of flexibility in the number of teams that are iced in Upper York but in the first year we didn't want to hold anybody back from rep hockey opportunities. I don't feel comfortable staining here that that we're not going to have double B teams at certain ages. I'm hoping that we're like minded with Georgina and that we examine the impact, if any, on our local programming when making those decisions.

I would also say to parents going forward, would be to please make sure that you're putting your kids in hockey, that where they're going be successful and and enjoy it. I think that, sometimes we lose sight of what the kids are looking for, which is just fun playing hockey. I'm never happy about putting kids in a position where they get hammered and I think that I share that feeling with the President of Georgina. We spoken about it several times and we're looking to make sure that we don't make the same mistakes, learn from what we did last year.

Question: Is there an opportunity to include non-contact divisions in the Dunsmuir Tournament, many kids in those divisions want to play a home tournament?

• Due to challenges with ice availability, it would be challenging to add more divisions to the current Dunsmuir tournament weekend but we could look at perhaps adding a second weekend to that tournament but that will severely impact our House League programming. The new Spring Fling in April though will have non-contact divisions, we are hoping our home teams enter this one even though it isn't mandatory like the Dunsmuir is for A teams.

Question: Can we track or do we know how many kids that were on teams last year, didn't try out for teams this year?



• We don't currently have that information but it's something the coaches would likely know. We could ask the Upper York Administrator if this is something she tracks.
